

# **Guidelines and Fee structure for accessing the Viral BSL-3 facility at IISc.**

## **Requirements**

1. IBSC (Institutional Bio-safety Committee) approval of project.
2. IAEC (Institutional Animal Ethics Committee) approval of project (for animal work).
3. IHEC (Institutional Human Ethics Committee) approval (for human origin samples).
4. Viral BSL-3 request form dully filled and signed by the PI.
5. Medical information sheet dully filled and signed by the PI.
6. Medical Insurance policy of users.
7. Debit head information to collect Access Fee

## **Instructions: -**

1. Viral BSL-3 in-charge and CIDR convenor need all the above documents duly signed by the PI before starting work in the BSL-3. After approval, users will have to go through One week training at Viral BSL-3 regarding working procedures at BSL-3 and good microbial practices.
2. Followed this training, Viral BSL-3 users will have to pass a questionnaire with >80% marks and work under observation for a week. Only after passing the written exam and satisfactory performance during observation, the trainee will be allowed to work inside BSL-3 lab independently.
3. For animal work, investigators must submit a detail work plan with time points to the Viral BSL-3 in-charge. After checking the availability of space at the A-BSL-3, investigators will be getting an intimation from the A-BSL-3 in-charge. After confirmation by investigators, the booking of investigators will be done.
4. Animal work will be done based on first come first work basis, strictly in accordance with the CPCSEA (committee for the purpose of control and supervision on experiments on animals) guidelines.
5. Investigators might have to do minor adjustment in time points in case of overlap with the time points of other investigators.
6. If the investigators are not able to house their animals at A-BSL-3 on time, then their booking may be cancelled.
7. User must bring their own PPEs, and work out a plan with Viral-BSL3 in-charge to contribute consumables for routine operation of the facility.

## Training and Access Fee

For access to Viral BSL3 facility, user will have to undergo 2-week training, that will include 1 week orientation, examination followed by 1 week of supervised working in the facility. See guideline document for details.

User will pay one time training fee and facility access charges on per session basis, as indicated in the table.

## Personal Protective Equipment

Users will have to bring their own PPE kits (which includes Tyvek suit, disposable surgical gown, surgical mask, N95 respirator, head cover, shoe cover, boot cover, ankle length shoe cover, long sleeve gloves, surgical gloves, sleeve cover, face shield) which costs approx. ₹1000. We can share the vendor information if needed, or PIs can source the materials from their preferred supplier.

**PPEs are for single time use only.**

Users must also bring a pair of rubber shoes (toes covered) and pair of washable scrubs for working in viral BSL3.

## Consumables

User will have to bring their own plasticware and consumables for cell culture and animal experimentation.
